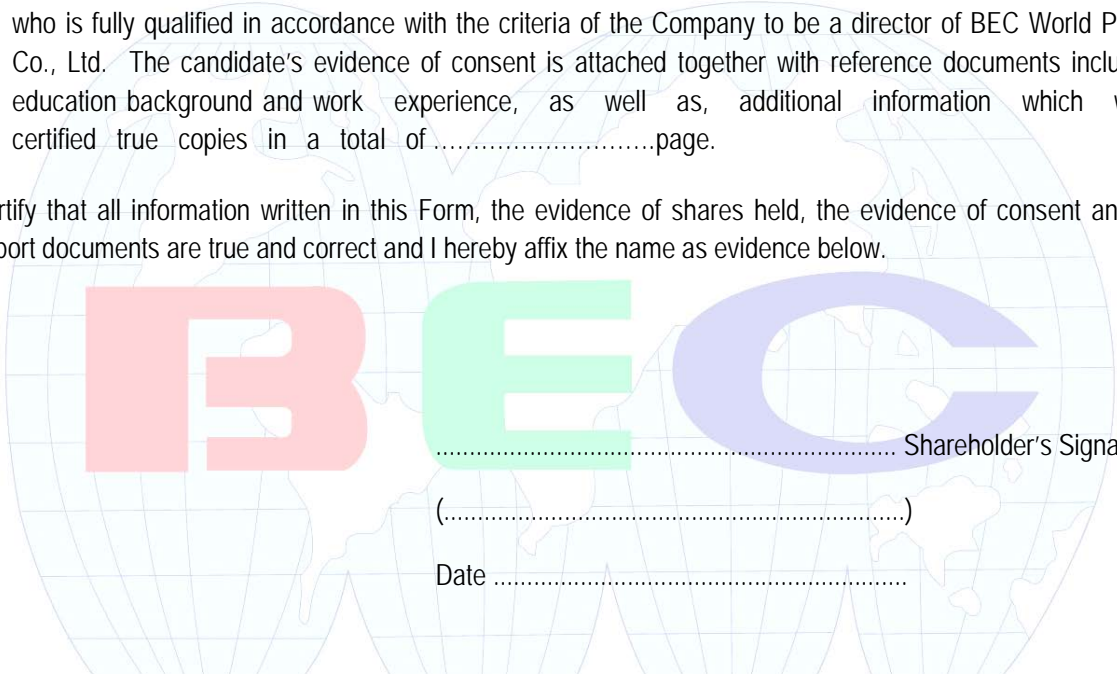

**Remarks** The Shareholder provide the following important details for consideration:

1. Evidence of shareholding

i.e. certified true copy of certificate of shares or certificate of shares issued by a broker or Thailand Securities Depository Co., Ltd. or any other evidence from the Stock Exchange of Thailand.

2. Evidence of Identification

(2.1) For Individual

Certified true copy of the identification card or government officer identification card or passport (in case of foreigners) of the shareholder which has not expired.

(2.2) For Juristic Person

Certified true copy of the certificate of juristic person which is issued no longer than 1 (one) month ago and copy of the identification card or passport (in case of foreigners) which has not expired of the authorized directors who signed in the Form for Proposing Director Candidate in Advance and affixed with juristic person's seal (if any).

If combined shareholders wish to propose the director candidate, the first shareholder must completely fill the Form in every title, (1) to (3) and affix the name as evidence. The rest shareholders must fill the Form in only title (1) and (2) and affix their names as evidence separately, then gather each of these forms into one set and deliver to the Company address.

4. The original of this Form must be delivered to the Company within 31 December 2018. The postage stamp date is considered as the criteria.
